2 External auditor report 2017/18

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review:

- An outstanding credit card balance at the year end has been incorrectly included in the bank reconciliation. The figure in Section 2, Box 8 should read £1,085,607 and the balance on the credit card should feature as another reconciling item between Boxes 7 and 8. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR.
