### WG/10/22 Grant Applications

i. **Keech Hospice** (Grant Application 006/21-22/Sect 137)

The Working Group noted the Grant Evaluation received from Keech Hospice following the grant of £500 awarded in July 2021.

### WG/11/22 Summer Programme

The Working Group noted the suggestion to consider any activities for inclusion in the 2022 Summer Activity Programme. The Working Group further noted that Springfield Initiative have advised that they will not be able to deliver a summer youth camp this year. Cllr Kavarana to investigate the reasons further and provide an update to the next meeting.

Working Group noted that MK Play Association hope to deliver play sessions at the Pirate Park in Fishermead during the summer, subject to a successful HAF funding bid.

### WG/12/22 Woolstone Play Area Project - CIF 2022/23 (Council Minute 235/21)

The Working Group received a verbal update from the Committee Clerk on the progress with the Woolstone (Pattison Lane/Butterfield Close) play area improvement project, which will be jointly funded by CPPC and MK Council with a total budget of £20k. The Working Group noted that resident consultation was included in the May edition of Homeground. The Committee Clerk outlined the costs received from MK Council today for a basic refurbishment scheme – total cost £22,040. The proposal will be circulated to members by email, with any comments to be sent to the Committee Clerk.

The Working Group resolved that the costed proposal be presented to Council for agreement prior to progressing with MK Council.

**Jubilee Big Lunch** at Sheltered Housing centres in the Parish – Dexter House have accepted our offer of support for their Jubilee Big Lunch, with party decorations provided to them by CPPC.

**Jubilee Rose** – Dexter House has expressed an interest in taking part in this project.

**Tree Planting** – the Landscape team are co-ordinating the planting of trees provided to CPPC from MK Council Green Canopy project. Suggestions of tree planting schemes have been received from residents in Woolstone and Willen, the details and costs of which need to be considered further.

**School Bunting** – Committee Clerk advised the Working Group that Jubilee Wood School and Oldbrook First School had both responded to the Committee Clerks request for help with the children making bunting for Dexter House's Jubilee Lunch.
